#### Happy New Year!

This is the first newsletter of 2018 and it is full of a lot of important reminders. I hope everyone has a great second semester / second half of the year!

#### **Provincial Election Preparation**

After the recent Patrick Brown departure as the leader of the Progressive Conservatives, I am sure many of you have started to think about the upcoming June 7<sup>th</sup> Ontario Provincial election.

Provincially, OSSTF has been planning our approach to this election for months. This past week OSSTF released our Platform for Education that we are hoping will be picked up by any, or all of the provincial parties. I would encourage you to check out our platform, "Public Education - It's for Everyone "which can be found on our Provincial website.

Locally, there is currently only one candidate for election in the Renfrew Nippissing Pembroke riding, PC incumbent John Yakabuski. I will be sitting down with John in the coming weeks to review our OSSTF platform and encourage him to adopt as many of our planks as I can (wish me luck). After meeting with Mr. Yakabuski, I will be joining other local leaders from around the province to discuss next steps in Toronto on February 22<sup>nd</sup>. Stay tuned for updates as we get closer to the election.

#### Retirement Workshops

There are two retirement workshops being offered by OTIP this spring. Both workshops run from 4:30 to 7:30 pm and include a free meal. #### Long Term Disability Changes

Members who are covered by Long Term Disability Insurance (LTD) will see some changes to their plan effective March 1st. The increased use of the provincial LTD plan has led to a plan deficit that needs to be addressed. There are only two possible solutions to fix the deficit - increased premiums or decreased benefits; the plan is choosing to use both.

1. The Benefit Level will be 50% of pre-disability salary (previously 55%.)

- 2. The maximum benefit period will be the earlier of: i) the end of the month of attaining age 65; or ii) the date the member becomes eligible for a 60% unreduced service pension (previously age 65 or 64% USP.)
- 3. The Waiting Period will be the later of 110 working days or expiration of sick leave, to a maximum of 24 months (previously 80 WD or expiration of sick leave, max 24 months).
- 4. Premiums will increase from 1.52% to 1.58% of salary (including RST). This represents an increase of 3.9%, rather than the increase of 29.5% that would otherwise have been required without the changes described in 1-3.

#### Health and Dental Benefits

There have been challenges in the processing of data sent by Boards going to OTIP for the OSSTF Employee Life and Health Trust (ELHT). With Semester 2 about to begin, this is a time when there are a relatively high number of benefit-related changes occurring, including new hires, commencement of new leaves of absence or members returning from a leave, FTE status changes, etc. If you are going through a status change please watch for emails from OTIP regarding new benefit elections and monitor the level of your OSSTF Benefits payroll deductions. # OHIP + and Exceptional Access Program

On January 1, 2018, the Ontario Ministry of Health and Long-Term Care (MOHLTC) introduced OHIP+: Children and Youth Pharmacare. Ontario residents who are 24-years-old or younger will be able to get their prescription medications for free under the new OHIP+ program. Enrolment and drug coverage will be automatic, with no upfront costs such as co-payments or deductibles.

The new program will cover all drugs currently reimbursed through the Ontario Drug Benefit (ODB) program. This includes more than 4,400 drug products listed on the ODB Formulary/Comparative Drug Index and additional drugs eligible for funding through the Exceptional Access Program (EAP) provided by the Ontario Ministry of Health and Long-Term Care. Therefore, medication that may be considered for funding through the EAP will not be covered under the OSSTF Benefits ELHT plan effective April 1, 2018, unless you take the following steps:

Speak with your prescribing doctor/nurse practitioner to:

- 1.Ask if there is a suitable alternative drug covered on the Ontario Drug Benefit Formulary that can be prescribed instead of the EAP drug. Or,
- 2.Request that they complete an EAP application for coverage for the EAP drug. The approval process can take a few weeks. Please take action now, so you are not paying out-of-pocket the next time you get the prescription filled.

NOTE: At the beginning of January, a notice was sent out from the insurer (Manulife Financial) and OTIP to members who are currently using EAP drugs, to give them sufficient time to apply for EAP funding.

#### Income Tax Returns

If you are currently covered by the OSSTF ELHT you should have already received an email from OTIP warning you not to complete your income tax return until you receive a T4A from the ELHT. Since your Basic Life and accidental death and dismemberment (AD&D) benefits are paid for by the OSSTF Benefits Employee Life and Health Trust (ELHT) plan, you will be receiving T4A tax slips for these taxable benefits by the end of February. (NOTE: If you are a Quebec resident, you will also see the funded health and dental amounts reported on the T4A tax slips.)

These taxable benefit amounts were calculated based on the portion of the negotiated funding used to pay for the life and AD&D benefits for the 2017 calendar year (January to December).

In the past, these amounts would have been reported to you on your T4A from the Board.

#### OTIP/OTF Teaching Awards

The Ontario Teachers Insurance Plan (OTIP) and the Ontario Teachers' Federation (OTF) are proud sponsors of the OTIP Teaching Awards.

For many years, these awards have recognized the excellence of teachers in publicly funded education. There are three categories of awards: elementary school teacher, secondary school teacher and beginning teacher in the first five years of teaching. A teacher may be nominated by anyone – professional colleagues, students, parents, or the general public. Nominations are now open for the 2018 awards. The Board can track internet activity even if a member is at home and using their own computer or device if they are logged into their Board email account. While it is in highly unlikely that the Board will take steps to monitor member activity, it is critical that members are aware that it is possible.
